Limited to one (1) bone anchored hearing aid during the period of time the member is enrolled in the Health Plan (per lifetime). Repairs and/or replacement for a bone anchored hearing aid are not covered, except for malfunctions. Deluxe model and upgrades that are not medically necessary are not covered.

Except in the case of a Medically Necessary Emergency or an Urgently Needed Service (outside geographic area served by your PacifiCare SignatureValue-Advantage Participating Medical Group), each of the above-noted benefits is covered when authorized by your PacifiCare SignatureValue-Advantage Participating Medical Group or PacifiCare. A Utilization Review Committee may review the request for services.
